Preface:

When selecting and citing an image, graph, chart, figure, video, audio file, or other form of multimedia for use by The International Scholar (ITS), it is necessary to abide by all relevant licensing and attribution rules to avoid violating copyright law. Should a copyright issue arise, the individual in question will be legally responsible for any and all liabilities resulting from the violation or infringement of copyright laws that were perpetuated through The International Scholar.

The ITS Attributions Guide is the intellectual property of The International Scholar, and intended for **personal use only**. You may not share, publish, reproduce, distribute, or transmit this document in part or in full in any form or by any means.

Photos

- In principle, there are six types of image licenses — outside of the Public Domain — that require attribution per Creative Commons. A useful acronym for remembering the key elements of attribution is TASL: Title, Author (legal name or username), Source (URL or hyperlink), and the type of License the image is available under, as well as a [link](#) to the license deed. If the author has certain attribution requests — such as they do not wish to be referenced by name — then abide by all given requests. If the image was modified in any way, shape, or form, an additional line of attribution stating what modifications were made is required (e.g., "desaturated from original"). In instances where there is no clear author for the photo, simply do not use the image.

Common, acceptable sources that ITS often peruses for images:

- Flickr
 - License type: Creative Commons licenses.
- Google Images
 - Select "tools"; license type; Creative Commons licenses.
- Pexels
 - All photos are free to use without attribution.
- Unsplash
 - All photos are free to use without attribution.

Guide to Photo Licensing Types

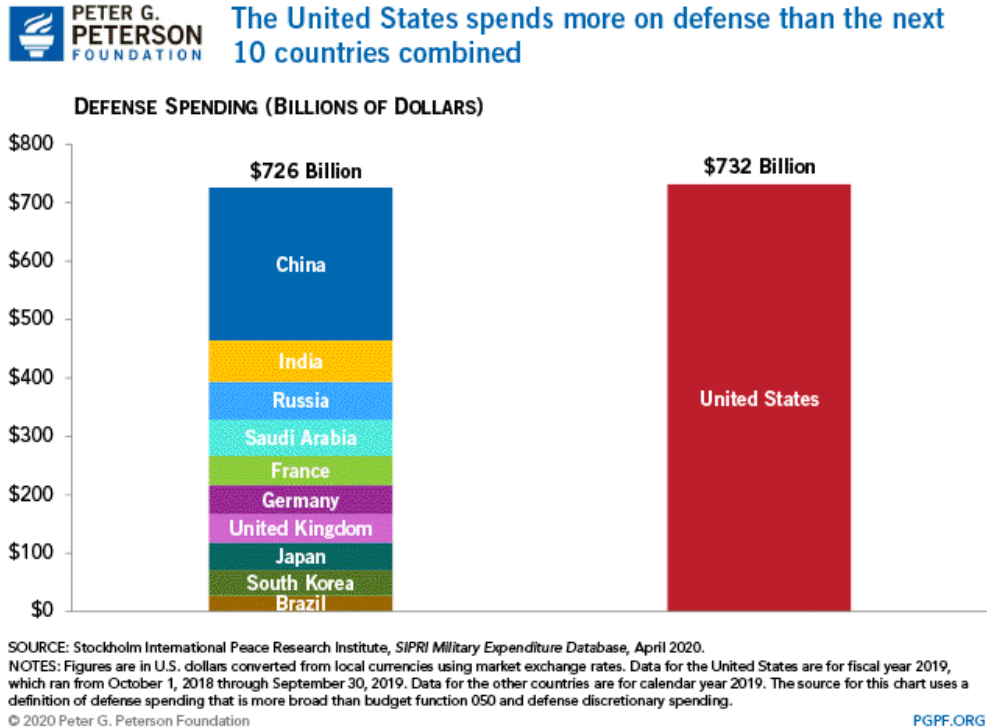
1. Public Domain
 - a. Public Domain images are not protected by any form of copyright — or the copyright has expired — as they currently exist. These types of images can be used by almost any individual, company, or organization for personal and commercial reasons without necessary legal attribution. However, providing attribution is strongly suggested regardless of whether or not the image is Public Domain, which covers all material published by the United States prior to 1923.
2. [Creative Commons](#)
 - a. Attribution (CC BY): "This license lets others distribute, remix, adapt, and build upon your work, even commercially, as long as they credit you for the original creation. This is the most accommodating of licenses offered. Recommended for maximum dissemination and use of licensed materials."
 - b. Attribution-ShareAlike (CC BY-SA): "This license lets others remix, adapt, and build upon your work even for commercial purposes, as long as they credit you and license their new creations under the identical terms. This license is often compared

to "copyleft" free and open source software licenses. All new works based on yours will carry the same license, so any derivatives will also allow commercial use. This is the license used by Wikipedia, and is recommended for materials that would benefit from incorporating content from Wikipedia and similarly licensed projects."

- c. Attribution-NoDerivs (CC BY-ND): "This license lets others reuse the work for any purpose, including commercially; however, it cannot be shared with others in adapted form, and credit must be provided to you."
 - d. Attribution-NonCommercial (CC BY-NC): "This license lets others remix, adapt, and build upon your work non-commercially, and although their new works must also acknowledge you and be non-commercial, they don't have to license their derivative works on the same terms."
 - e. Attribution-NonCommercial-ShareAlike (CC BY-NC-SA): "This license lets others remix, adapt, and build upon your work non-commercially, as long as they credit you and license their new creations under the identical terms."
 - f. Attribution-Non-Commercial-NoDerivs (CC BY-NC-ND): "This license is the most restrictive of our six main licenses, only allowing others to download your works and share them with others as long as they credit you, but they can't change them in any way or use them commercially."
3. Stock Photos
 - a. Stock photos include images that creators lease out to individuals, companies, or organizations who are willing to pay the creator's licensing fee. Generally avoid stock photos; however, in instances where a stock photo is purchased for use, the photo may be used in any way that is acceptable according to the creator's licensing agreement.
 4. Personal Images
 - a. If the image in question is of personal origin — as in the photo was taken by the writer or editor themselves — then there are no attribution requirements.
 5. Reusing Social Media Images
 - a. To reuse or reshare images already posted on social media platforms, it is necessary to still abide by all applicable attribution rules. To correctly attribute the photo, reach out to the original account from which the photo was posted and explicitly ask for permission to reuse on behalf of The International Scholar. If permission is granted, attribute the image as needed according to the licensing rules stated above.
 6. GIFs
 - a. Do not use GIFs under any circumstance.

Graphs, Charts, & Figures

- When citing a graph, chart, or figure, it is necessary to provide a caption that includes in some fashion: 1) the title of the work and/or what the work shows, and 2) a credit line that mentions and/or links to the source.
- While there is no definitive structure or format for a caption, the aforementioned information must be provided below the image within the text. If any other sources were used, mention them alongside the term "Source." In the caption, label the works as they appear alongside the term "Fig." or "Figure" and place a period after the figure number (e.g., "Fig. 1." or "Figure 1."). When positioning within the text, center the graph, chart, or figure on the page and left-justify the caption.

Videos & Audio Files

- When attributing or citing a video or audio file, include the same elements in the caption as mentioned in the attribution acronym "TASL": Title, Author, Source, and License. Be sure to mention the date and medium if possible (e.g. DVD or CD).
